Dear Rodger,

On behalf of everyone at the Royal Flying Doctor Service Qld Section (RFDS), I would like to thank you for offering to raise funds for the RFDS through your fundraising activity of the Bullo River Station Trail Ride as described in your registration form.

All funds donated to the RFDS go towards the replacement of ageing aircraft and to update vital medical equipment as well as bridging the shortfall in operational funding. Your contribution will assist the RFDS in servicing the medical needs of all Queenslanders by providing equitable access to comprehensive quality healthcare, regardless of location.

This letter acts as confirmation that you are officially supporting the RFDS.

### **Authority to Fundraise**

The Royal Flying Doctor Service Qld Section authorises the 'Fundraiser', Rodger Parker, of 1953 Mt. Mee Road, Ocean View QLD 4521, to fundraise on behalf of RFDS on the following terms and conditions:

1. The Fundraiser is authorised to conduct the Bullo River Station Trail Ride event and accept cash and cheque donations from 22 July 2010 to 30 September 2011.
2. The Fundraiser will keep the proceeds of the Bullo River Station Trail Ride event in a safe and secure place and will bank the proceeds into the RFDS ANZ bank account; BSB 014-002 A/C No 361064704.
3. Upon receipt of the funds, RFDS will issue tax deductible receipts to people donating \$2 or more, where the donation is a gift and RFDS has received a Receipt Request Form from the Fundraiser.
4. The Fundraiser undertakes to provide a basic income and expenditure statement indicating all costs associated with the event and total income within four weeks of the conclusion of the event. Fair and reasonable costs incurred in organising the activity may be deducted but these must not exceed 40% of total income raised. The RFDS will not be able to incur any expenditure for the event or activity.
5. Funds raised on behalf of RFDS cannot be used to make a donation to another organisation.

The RFDS confirms that the Bullo River Station Trail Ride activity will be covered under the organisation's public liability insurance policy based on the information provided on the Community Fundraising Registration Form provided by the Fundraiser. Should any material details of the activity change, the Fundraiser undertakes to immediately inform the RFDS of the changes. The details will be forwarded to the insurer for confirmation that public liability insurance cover can still be offered.
